TERMS AND CONDITIONS

Terms, pending credit approval, are net cash within thirty days of shipment (F.O.B. Midvale, UT) and will be issued upon shipment date. Buyer agrees to pay such invoices when due. Zenergy Music reserves the right to refuse to sell to any retailer whose credit is not satisfactorily maintained. Should termination occur, all invoices must be paid in full and merchandise may not be returned to offset account balance. Prices and charges are for domestic orders only.

Invoices not paid within the designated thirty day terms are subject to a 2.5% per month late payment charge assessed against any unpaid balance from the due date of the invoice until payment is received.

Buyer is responsible for, and assumes all risk of loss or damage to, the goods, from any cause, upon and after delivery by Seller to the carrier. The risk of loss shall not be altered by conduct of either party hereto.

Seller warrants to buyer a period of sixty days from the date of delivery that the goods will be free from defects of materials and workmanship when properly used and maintained.

Warranty claim shall be made by buyer in writing. Seller's sole obligation under the forgoing warranty is, at Seller's option, to repair, replace or correct any such defect that was present at the time of delivery or to remove the goods and to refund the purchase price to Buyer.

EXCEPT AS STATED ABOVE, SELLER MAKES NO OTHER WARRANTIES, EXPRESSED OR IMPLIED WITH RESPECT TO THE GOODS AND SELLER EXPRESSLY DISCLAIMS ANY EXPRESS OR IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. BUYER PURCHASES AND ACCEPTS GOODS SOLELY ON THE BASIS OF THE LIMITED WARRANTY HEREINABOVE EXPRESSED. SELLER FURTHER EXPRESSLY DISCLAIMS ANY LIABILITY FOR SPECIAL INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING AS A RESULT OF OR IN CONNECTION WITH THE GOODS. NOTWITHSTANDING THE FOREGOING, SELLER'S LIABILITY HEREUNDER SHALL BE LIMITED IN AMOUNT TO THE PURCHASE PRICE OF THE INDIVIDUAL GOODS.

If any of the foregoing terms and conditions conflict with any made in the Buyer's purchase order, our catalog or otherwise made by Seller's personnel, the above stated terms and conditions shall prevail.

ELECTRONIC LISTENING STATIONS

Passport Music listening station cabinet and interactive electronics are available to active dealers only at the discretion of Zenergy Music. No other music or products may be merchandised in the Zenergy Music Listening Station. Retailer agrees to return display and / or electronic components of listening station if and when dealer is no longer active.

FREIGHT

Freight will be billed back to Buyer on the invoice F.O.B. Midvale, UT, or Buyer may arrange for pickup.

RETURNED CHECKS

There will be a \$25.00 charge for any returned checks.

EXCHANGE POLICY

Seller offers a limited exchange policy on total purchases for the previous 120 days. Exchange privilege will be credited against future purchases only. Exchanges will be accepted only for products in Seller's current catalog. Only current accounts may exercise this exchange policy.

All exchanges must have an exchange authorization number provided by our customer service department. All exchanges must be sent freight pre-paid. Exchanges sent without Seller's exchange authorization number or exchanges shipped freight collect will be refused. Exchanges apply only to titles in the current catalog and must be in saleable condition. **All store stickers must be removed prior to returning to avoid a \$1.00 charge for reshrinkwrap. Cracked CD cases will incur a \$2.00 charge for replacement and shrinkwrap.**
